

ORDINANCE NO. A- 436

WHEREAS, a petition was duly filed with the City Council of the City of Conway, Arkansas, on the ~~13~~<sup>12</sup>th day of April, 1966, asking the City Council to vacate and abandon a certain alley lying within Block Six (6), Srygley Addition to the City of Conway, Arkansas, a more particular description of said alley being set forth in said petition and in Section One of this ordinance; and,

WHEREAS, attached to said petition is a certified copy of the portion of the plat filed in the office of the Recorder of Faulkner County, Arkansas, showing the said alley in said Block Six (6), Srygley Addition to the City of Conway, Arkansas, together with the Lot numbers of each lot which abuts on the said alley hereinafter described; and,

WHEREAS, after due notice, as required by law, the Council has, at the time **and place** mentioned in the notice, heard all persons desiring to be heard on the question, and has ascertained that said alley hereinabove mentioned and hereinafter described has heretofore been dedicated to the public use as an alley, and has not been actually used by the public generally for a period of at least five years subsequent to the filing of the above mentioned plat and before the Filing of the above petition;--that all the owners of property abutting upon said alley sought to be vacated have filed with the City Council their written **consent** to such abandonment; and that the public interest and welfare **will not** be adversely affected by the abandonment of said alley.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS :

Section 1. The City of Conway, Arkansas. hereby releases, vacates and abandons all its rights, subject to the limitations and reservations in Section 2 hereof, together with the rights of the public generally, in and to the alley lying within Block Six, Srygley Addition to the

City of Conway, Arkansas, a more particular description of said alley being as follows:

Beginning at the Southeast corner of Lot One (1) and run thence Nest along the South line of Lsts One (1), Two (2), Three (3), Four (4) and Five (5) and to the Southwest corner of Lot Five (5); thence South Seventeen (17) feet to the Northwest corner of Lot Six (6); thence East along the North line of Lots Six (6), Seven (7), Eight (8), Nine (9) and Ten (10) and to the Northeast corner of Lot Six (6); thence North Seventeen (17) feet and to the Southeast corner of Lot One (1) and the point of beginning, all of said lots being in Block Si (6), Srygley Addition to the City of Conway, Arkansas, according to a nap of said City made by B. G. Wilson and filed for record July 3, 1917;

All of said properby being shown on Map of said City of Conway made by B. G. Wilson and filed for record July, 1917.

SECTION 2. A copy of this ordinance, duly certified by the City Clerk, shall be filed in the office of the Recorder of Deeds of Faulkner County, Arkansas.

SECTION 3. This ordinance shall take effect and be in force from and after its passage and publication.
