

ORDINANCE NO. A-449

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF CONWAY, ARKANSAS; DECLARING SUCH TERRITORY TO BE A PART OF SAID CITY; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, certain property owners lying adjacent to the city limits of Conway, Arkansas, did petition the County Court of Faulkner County, Arkansas for an order annexing the hereinafter described territory to said City; and


WHEREAS, after proceedings being had upon notice by publication all as provided by and in accordance with the laws of the State of Arkansas, the judge of the County Court of Faulkner County, Arkansas, did, on December 22, 1966 and March 1, 1967, enter his order of annexation to said City of the hereinafter described lands:


NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

SECTION 1. That the City Council of Conway, Arkansas does hereby accept the hereinafter described territory, annexed to said City by order of the County Court of Faulkner County, Arkansas, heretofore entered on December 22, 1966 and March 1, 1967, said territory being described as follows, to-wit:

Beginning at the Northwest Corner of the Northwest Quarter (NW $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Thirteen (13), Township Five (5) North, Range Fourteen (14) West, and running thence South 460 feet, thence East 1,200 feet, thence South 120 feet, thence East 378.78 feet, thence North 580 feet, thence West 1,578.78 feet to the point of beginning 17 acres more or less.

And that said above described lands and territory be, and the same hereby are, declared to be a part of the City of Conway, Faulkner County, Arkansas.
